

ORDINANCE NO: 2018-530

**AN ORDINANCE REGULATING THE OFF PREMISES SALE  
OF LIQUOR AND ALCOHOLIC BEVERAGES ON SUNDAY**

**WHEREAS**, the City of Pleasant Grove Ordinance No: 186, which was enacted by the City on or about December 16, 1974, authorized the sale of alcoholic beverages pursuant to the provisions of Title 37, Section 487 of the 1940 Code of Alabama; and,

**WHEREAS**, said Ordinance prohibited the sale of alcoholic beverages on Sundays as the law, at the time that Ordinance was adopted, prohibited sale of alcohol on Sunday throughout the State of Alabama; and,

**WHEREAS**, through acts of the Alabama Legislature otherwise codified in Section 45-37-22.03 and 45-37-22.04, all of which were enacted into law on March 16, 1990, allowed the sale of liquor throughout Jefferson County between the hours of 12 midnight and 2:00 A.M. on Sunday morning and upon 12:00 noon on Sundays through the following day; and,

**WHEREAS**, the City of Pleasant Grove has otherwise complied with State Law and the Ordinances enacted above, but has not formerly ordained the sale of liquor on and alcoholic beverages Sundays during the State allowed hours of sale and wishing to remove any confusion for any vendors or other establishments offering the sale of liquor and alcoholic beverages on Sundays.

**IT IS HEREBY ORDAINED AS FOLLOWS:**

1. That the sale of liquor and alcoholic beverages on Sunday shall, in accordance with the laws of the State of Alabama, be allowed between 12 midnight on Sunday through 2:00 A.M. on Sundays morning and from 12 noon on Sunday through the following 12 midnight.

2. Except as specified herein, the provisions of Ordinance No: 186, shall remain in full force and effect.

3. Should any portion of this Ordinance be found by any Court or other tribunal to be invalid or void, then un such event said invalid or void provision shall be stricken, but the remainder hereof shall remain in full force and effect.

4. This Ordinance shall become valid on the date herein listed.


